The Pre-Medical Certificate is a contracted, premium tuition program designed exclusively for the federal contract with the Uniformed Services University of Health Sciences (USUHS) and is only open to active duty enlisted military members selected by the Department of Defense. USUHS asked us to make some minor modifications to the Pre-Medical Certificate.

- 1. Add an additional summer semester to the start of the program to allow for 4 more credits to be added to the curriculum. (Students will now attend summer, fall, spring, summer.)
- 2. CHEM 211 and CHEM 213 will be moved from the fall semester to the first summer semester.
- 3. CHEM 212 and CHEM 214 will be moved from the spring semester to the fall semester.
- 4. CHEM 463 (Biochemistry) will be added to the curriculum and will be offered in the spring semester.
- 5. MATH 113 (Calculus) will be deleted from the curriculum since most medical schools no longer require calculus as a pre-requisite.
- 6. BIOL 214 (Biostatistics) will be added to the curriculum since this course is a required pre-requisite for application to medical school.

7. The total credits for the PMCL will now be 42 credits and the program will run from summer through the following summer. (The program is based on a cohort system.)
